## TETFund Team says MOUAU stands out among others in Institutional Research

National Research Fund (NRF) Monitoring and Verification team from the Tertiary Education Trust Fund (TETFund) says Michael Okpara University of Agriculture, Umudike, (MOUAU) stands out among other tertiary institutions in Nigeria in its commitment to institutional and impactful scientific research.

Leader of the Team, Emeritus Prof. Olugbemiro Jegede stated this while addressing the University Management after inspecting some ongoing research projects in the University last week..

"Forget about ranking, most of which are skewed and not reflecting reality; we did not make a mistake when we decided to visit Umudike first. We listened to all the researchers; they are professionals in their fields. Their research topics were timely and are reactive to the needs of the society. We think Umudike stands out and we are not disappointed", Prof. Jegede said.

Further, he said his team would recommend to TETFund to complete its funding of research projects in MOUAU and provide more resources to spur the researchers to undertake more research activities.

In his welcome remarks, the Vice-Chancellor of MOUAU, Prof. Maduebibisi Ofo Iwe, represented by the DVC, Administration, Prof. Ursula Ngozi Akanwa, commended TETFund for its invaluable

contributions to tertiary education in Nigeria, adding that MOUAU as a benefiary remains open to suggestions that would help to improve its institutional research efforts.

MOUAU News gathered that the National Research Fund (NRF) monitoring exercise is aimed at assessing the implementation, progress and impact of TETFund sponsored research projects across institutions to ensure compliance to standards.



Speaking to MOUAU News, the Dean of Students Affairs, Prof. Onwuchekwa Raphael Iheke, expressed satisfaction with the outcome and praised the Vice-Chancellor and University Management

for sustaining the e-voting initiative. He noted that the digital process has significantly reduced electoral malpractice, violence, and rigging.

Said Prof. Iheke "the e-voting system is a step in the right direction. It has brought peace, transparency, and convenience to our electoral process".

#### TERMINATION OF CONTRACT AWARDS

Re: Award of Contract for Years 2017, 2018, & 2019 (Merged) TETFund Normal Intervention Projects:

Lot 1: Construction of Classrooms and Offices for College of Natural and Environmental Management (CNREM).

Lot 4: Construction of Offices and Classrooms Block for College of Agricultural Economics, Rural Sociology and Extension (CAERSE)

You may recall that based on the Administrative Review as requested by you and in compliance with the Bureau of Public Procurement (BPP) directives, the initial Contract awards for the above Projects (Lots 1 & 4) were determined and re-awarded to you vide award letters dated 26th July, 2022 with completion period of six (6) and three (3) months respectively.

You applied and received Mobilization Advances of the sum of ₹52,695,188.57 and ₹24,421,782.14 for Lot 1 and Lot 4 respectively. Your accomplishment was insignificant compared to the scope of work. You stopped work in the absence of frustrating circumstances and left site since December, 2022. You ignored all efforts made for you to come back to site and utilize the project funds paid to you.

The University (Client) takes your actions as Fundamental Breaches of the Contracts, and in a letter dated 20th June, 2023 notified you of her intention to determine these Contracts.

You are invited as directed by the Bureau of Public Procurement (BPP), two weeks from receipt of this letter, to a Tripartite Evaluation of works done by you on the Projects vis-a-vis Advance payment on the Projects. Your failure to comply shall leave the University with no option than to escalate the matter to the relevant Anti-graft Agencies for necessary action.

Consequent upon the above and in compliance with Bureau of Public Procurement (BPP) directives for the University to take all necessary actions to salvage the projects in line with the Conditions of Contract, the Contracts awarded to you for execution of the underlisted Projects are deemed terminated.

Lot 1: Constructon of Classrooms and Offices for College of Natural and Environmental Management (CNREM).

Lot 4: Construction of Offices and classroom Block for College of Agricultural Economics, Rural Sociology and Extension (CAERSE).
